### Actual Gas sales volume in March 2003

Total gas sales volume by Tokyo Gas Co., Ltd., for the month of March 2003 came to about 1,090.3 million m<sup>3</sup>, up 222.9 million m<sup>3</sup> (or 25.7%) from March 2002.

In the residential sector, volume totaled about 394.9 million m<sup>3</sup>, up 19.1% from March 2002. The increase was due to the lower temperature than last year, which caused more demand in hot water and heating.

In the business sector (consisting of commercial, public, and medical use), volume amounted to about 234.2 million m<sup>3</sup>, up 24.9% from March 2002. This increase was due to the added consumption by new customers and the lower temperature that caused more demand in hot water supply and air conditioning systems.

In the industrial sector, factors such as increased consumption by existing customers brought volume to about 356.4 million m<sup>3</sup>, up 35.2% from the previous March.

Volume for wholesale supply to other gas companies totaled about 104.7 million m<sup>3</sup>, up 23.6% from March 2002, due to an increased off-take volume by contracted gas companies.

#### Gas sales volume in FY 2002

In FY 2002 (from 1 April 2002 to 31 March 2003), gas sales totaled 10,463.8 million m3, up 13.5% from FY 2001.

In the residential sector, sales volume came to about 3,254.2 million m3, up 5.9% from FY 2001, due to the lower temperatures than last year, which caused more demand in hot water and heating.

In the business sector, sales hit about 2,503.4 million m3, up 9.6% from FY 2001, due to the added consumption by new customers and the lower temperature that caused more demand in hot water supply and air conditioning systems

In the industrial sector, the volume reached about 3,598.7 million m3, up about 23.6% from FY 2001, due to the increased consumption by existing customers.

Wholesale supply to other gas companies came to 1,107.5 million m3, up 16.5% from FY 2001, due to an increased off-take volume by contracted gas companies.
