Actual Gas Sales volume in August 2008

Tokyo Gas Co., Ltd.

Total gas sales volume by Tokyo Gas Co., Ltd., for the month of August 2008 came to about 1,039.764 million m³, down 40.201 million m³ (or -3.7%) from August 2007.

In the residential sector, volume totaled about 133.217 million m3, down 8.9% from August 2007 due to higher temperatures than last year in the average of July and August, which caused less demand in hot water.

In the business sector (consisting of commercial, public, and medical use), volume totaled about 293.656 million m³. This is about the same volume as the same month last year (down about 0.3% from August 2007).

In the industrial sector, volume totaled about 457.680 million m3, down 6.3% from last year because the counted days were fewer than that of previous year.

Volume for wholesale supply to other gas companies totaled about 155.212 million m³, up 2.9% from August 2007, due to new demand by contracted gas companies.

On a cumulative basis, the volume from April 2008 up to and including August 2008 totaled 5,527.193 million m³, an increase of 3.0% from the same period of 2007.
