## Restructuring and Consolidation of City Gas business and LPG business in Yamanashi prefecture

Tokyo Gas Co., Ltd. announced today the restructuring and consolidation of Tokyo Gas Group's city gas and LPG businesses in Yamanashi prefecture. A new company will be established on October 1<sup>st</sup>, 2009. (The company name is undecided. Hereinafter called "Yamanashi new company")

Teikoku Oil Co., Ltd. plans to make a 10% investment in this Yamanashi new company for and the companies will start negotiations for specific conditions. After this consolidation, Yamanashi new company will engage in both city gas and LPG businesses as a community-based company.

 Tokyo Gas group's gas business in Yamanashi prefecture Tokyo Gas group has been conducting city gas and LPG businesses under several different enterprises in Yamanashi prefecture.

Tokyo Gas bought a local city gas company and founded Tokyo Gas Kofu branch in February,1945. It manages city gas business in Kofu city, Chuo city and Showa city in Yamanashi prefecture and the company supplies domestic natural gas which is bought from Teikoku Oil to about 30thousand customers, while Tokyo Gas Customer Service Co., Ltd. Kofu branch operates safety check of city gas appliances and reading meters, etc.

Showa Bussan Co., Ltd. And Tokyo Gas Energy Co., Ltd. Kofu branch which are Tokyo Gas group LPG companies supply LPG to 13thousand customers in Yamanashi prefecture.

 The reason and objective of establishing a new company Tokyo Gas has been studying the best business method to conduct a community-based gas company in Yamanashi prefecture. To strengthen its sales activities as well as realizing quick and deliberate services to our customers, while enhancing operational efficiency, Tokyo Gas decided today to reorganize city gas business and LPG business and consolidate into Yamanashi new company.

Yamanashi new company will take over the businesses now operated by Tokyo Gas Kofu branch on October 1st,2009、which will be divided from Tokyo Gas, as well as Showa Bussan, Tokyo Gas Energy Kofu branch. and Tokyo Gas Customer Kofu branch. The Yamanashi new company will become an integrated energy provider providing both city gas and LPG and will conduct business closely related to its local service area.

As for the legal procedure, Tokyo Gas Kofu branch will be divided from Tokyo Gas and Showa Bussan will become a successor by sink decomposition specified in corporate law.

Both Tokyo Gas and Tokyo Gas group aim to maximize corporate value by meeting customers' communities' and shareholders' needs while improving our service level catered to our local customers as well as business efficiency.
