Actual Gas Sales volume in August 2013 Tokyo Gas Co., Ltd.

Gas Sales Volume for the month August 2013

Total gas sales volume by Tokyo Gas Co., Ltd. for the month of August 2013 came to about 1,084.742 million m3, up 1.2% from August 2012.

In the residential sector, volume totaled 126.627 million m3, down 6.8% from August 2012, due to higher average temperature* compared to that in the same period last year, leading to the decreased demand for water-heating, and less metering days than those of last year.

In the business sector (consisting of commercial, public, and medical use), volume totaled 261.05 million m3, almost the same as August 2012 (down 0.3%).

In the industrial sector, volume totaled 534.594 million m3, up 5.1% from August 2012, leading to the increased demand for power generation.

Volume for wholesale supply to other gas companies totaled 162.47 million m3, down 1.5% from August 2012, due to the decreased demand of the other companies.
