# Actual Gas Sales volume in August 2015 Tokyo Gas Co., Ltd.

#### Gas Sales Volume for the month August 2015

Total gas sales volume by Tokyo Gas Co., Ltd. for the month of August 2015 came to about 1,221.792 million m3, up 4.0% from August 2014.

In the residential sector, volume totaled 130.676 million m3, almost equal (0.0%) to that in August 2014.

In the business sector (consisting of commercial, public, and medical use), volume totaled 258.677 million m3, up 4.1% from August 2014, due to more metering days compared to that in the same period last year.

In the industrial sector, volume totaled 648.891 million m3, up 4.1% from August 2014, due to the higher operation rate of existing customers' facilities.

Volume for wholesale supply to other gas companies totaled 183.548 million m3, up 6.4% from August 2014, due to the increased demand of the other companies.
