Gas Sales Volume for the month November 2015

Total gas sales volume by Tokyo Gas Co., Ltd. for the month of November 2015 came to about 1,205.147 million m3, up 2.3% from November 2014.

In the residential sector, volume totaled 232.363 million m3, down 7.1% from November 2014, due to higher average temperature*, leading to the decreased demand for water-heating and air-conditioning.

In the business sector (consisting of commercial, public, and medical use), volume totaled 170.383 million m3, down 2.7% from November 2014, due to higher average temperature*, leading to the decreased demand for water-heating and air-conditioning.

In the industrial sector, volume totaled 603.008 million m3, up 8.9% from November 2014, leading to the increased demand for power generation.

Volume for wholesale supply to other gas companies totaled 199.394 million m3, almost equal to that in November 2014 (up 0.1% from November 2014).
