

Actual Gas Sales volume in February 2016

Tokyo Gas Co., Ltd.

■ Gas Sales Volume for the month February 2016

Total gas sales volume by Tokyo Gas Co., Ltd. for the month of February 2016 came to about 1,471.195 million m³, down 3.0% from February 2015.

In the residential sector, volume totaled 430.967 million m³, down 4.5% from February 2015, due to higher average temperature*, leading to the decreased demand for water-heating and air-conditioning.

In the business sector (consisting of commercial, public, and medical use), volume totaled 248.692 million m³, down 3.2% from February 2015, due to higher average temperature*, leading to the decreased demand for water-heating and air-conditioning.

In the industrial sector, volume totaled 553.556 million m³, down 7.6% from February 2015, due to the decreased demand for power generation.

Volume for wholesale supply to other gas companies totaled 237.981 million m³, up 13.6% from February 2015, due to the increased demand of the other companies.
