# Actual Gas Sales volume in September 2009 and First Half 2009 Tokyo Gas Co., Ltd.

#### Gas Sales Volume for the month September 2009

Total gas sales volume by Tokyo Gas Co., Ltd., for the month of September 2009 came to about 931.962 million m<sup>3</sup>, down about 109.521 million m<sup>3</sup> (or 10.5%) from September 2008.

In the residential sector, volume totaled about 139.498 million m3, up 0.4% from September 2008.

In the business sector (consisting of commercial, public, and medical use), volume totaled about 238.972 million m<sup>3</sup>, down about 13.3%, due to lower average temperature in September compared to 2008, leading to decrease in air-conditioning demand as well as fewer number of metering days.

In the industrial sector, volume totaled about 390.469 million m3, down 15.4% from last year due to existing customers' demand decrease.

Volume for wholesale supply to other gas companies totaled about 163.023 million m<sup>3</sup>, down 1.5% from September 2008.

#### Gas Sales Volume for the first half of fiscal 2009

Gas sales volume in the first half of fiscal 2009 (April - September 2009) totaled about 5,938.424million m<sup>3</sup>, down by 9.6 % from the same period in fiscal year 2008. This was the first time in 32 years since 1977 for the gas sales volume to fall short of that of the previous year.

Of this total, the residential sector accounted for 1,259.864 million m<sup>3</sup>, down by 3.1% from the first half of fiscal year 2008. The decrease was due to the higher temperature during this period, which caused less demand in hot water.

Sales in the business sector amounted to 1,404.305 million m<sup>3</sup>, down by 2.8% from the same period of previous year, owing to higher temperature in spring which resulted in lower demand for hot water, and lower temperature in summer which caused less demand for air conditioning.

In the industrial sector, the volume totaled about 2,329.056 million m<sup>3</sup>, 17.9% down from the first half of fiscal 2008, due to production reduction in the existing customers.

Volume for wholesale supply to gas companies totaled about 945.199 million m<sup>3</sup>, down by 4.3% from the first half of fiscal 2008, due to a decreased off-take volume by contracted gas companies.
