1. Overview of Business Performance, etc.

(1) Overview of business performance for the six months ended September 30, 2025

(1) Business performance

City gas sales volume decreased by 0.4% year on year to 5,127 million m³, mainly due to a decrease in demand from industrial customers and for supply to other utilities as a result of a decrease in demand for industrial use and other factors. This was despite an increase in demand from residential customers mainly due to lower temperatures. The Group's net sales for the six months increased by ¥125,889 million (10.3%) to ¥1,347,520 million mainly due to an increase in electric power sales volume.

Operating expenses increased by ¥70,000 million (5.9%) year on year to ¥1,252,226 million due to an increase in power supply procurement costs and other factors.

As a result, operating profit increased by ¥55,889 million (141.8%) year on year to ¥95,294 million, and ordinary profit increased by ¥58,894 million (215.6%) to ¥86,203 million. Profit attributable to owners of parent increased by ¥113,646 million (708.8%) to ¥129,680 million after recording ¥11,707 million in gain on sale of non-current assets, ¥4,822 million in gain on sale of investment securities, and ¥68,013 million in gain on reversal of foreign currency translation adjustment as extraordinary gains and posting income taxes.

Segment earnings were as follows.

1) Energy solution

City gas sales volume to residential customers increased by 3.7% year on year to 952 million m³, mainly due to an increase in demand caused by lower temperatures. Sales volume to commercial and industrial customers decreased by 0.8% to 3,448 million m³, mainly due to a decrease in demand for industrial use, while supply to other utilities decreased by 4.0% to 728 million m³. Total sales volume decreased by 0.4% to 5,127 million m³.

Electric power sales volume to retail customers increased by 15.7% year on year to 7,987 million kWh, mainly as a result of an increase in the number of contracts, while sales volume to wholesale and other customers increased by 25.4% to 5,931 million kWh, primarily due to higher demand from wholesale customers. Total sales volume increased by 19.6% to 13,918 million kWh.

Sales increased by ¥108,224 million (9.9%) year on year to ¥1,196,042 million. Operating expenses increased by ¥62,818 million (6.1%) to ¥1,096,481 million, while the share of profit of entities accounted for using the equity method decreased by ¥596 million (63.6%) to ¥340 million. As a result, segment profit increased by ¥44,810 million (81.3%) to ¥99,901 million.

2) Network

Sales increased by ¥2,448 million (1.7%) year on year to ¥143,101 million, while operating expenses also increased by ¥3,415 million (2.2%) to ¥160,569 million. As a result, segment loss deteriorated by ¥966 million to ¥17,467 million.

3) Overseas

Sales increased by ¥21,539 million (24.3%) year on year to ¥110,295 million, while operating expenses also increased by ¥2,539 million (3.1%) to ¥84,333 million. The share of loss of entities accounted for using the equity method deteriorated by ¥2,576 million to ¥2,526 million. As a result, segment profit increased by ¥16,424 million (234.2%) to ¥23,436 million.

4) Urban development business

Sales decreased by ¥1,739 million (5.7%) year on year to ¥28,595 million, while operating expenses also decreased by ¥49 million (0.2%) to ¥22,555 million. The share of loss of entities accounted for using the equity method deteriorated by ¥479 million to ¥158 million. As a result, segment profit decreased by ¥2,170 million (27.0%) to ¥5,881 million.

(2) Financial position

While the business was generally affected by exchange rates, total assets at the end of the second quarter decreased by ¥189,931 million (4.9%) from the end of the prior fiscal year to ¥3,665,162 million. This mainly reflected a decrease in notes and accounts receivable – trade and contract assets due to seasonal factors, as well as a decrease in mining rights.

Liabilities decreased by ¥43,527 million (2.1%) from the end of the prior fiscal year to ¥2,010,096 million. This was mainly attributable to a decrease due to the repayment of long-term borrowings, which offset an increase in other current liabilities due to the issuance of commercial paper.

Net assets decreased by ¥146,404 million (8.1%) from the end of the prior fiscal year to ¥1,655,066 million. This was mainly due to a decrease of ¥132,505 million in accumulated other comprehensive income primarily as a result of a decrease of ¥7,459 million in shareholders' equity due to dividends of surplus and the purchase of treasury shares, as well as a decrease in foreign currency translation adjustment.

The equity ratio decreased by 1.5 percentage points to 43.3% as a result of the rate of decrease in equity capital (the sum of shareholders' equity and accumulated other comprehensive income) being greater than the rate of decrease in total capital.

Calculation of tax expenses

Tax expenses are calculated by making a reasonable estimate of the effective tax rate after applying tax effect accounting to profit before income taxes for the consolidated fiscal year that includes the six months period and multiplying the profit before income taxes by the estimated effective tax rate. However, in cases where the calculation of tax expenses using the estimated effective tax rate results in a significant lack of rationality, tax expenses are calculated using the statutory effective tax rate.

(Changes in accounting policies)

Application of accounting treatment in accordance with U.S. GAAP by U.S. consolidated subsidiaries

Tokyo Gas America Ltd., the Company's U.S. consolidated subsidiary, and its affiliated consolidated subsidiaries prepared financial statements in accordance with the International Financial Reporting Standards (IFRS) but have adopted Generally Accepted Accounting Principles in the U.S. (U.S. GAAP) for their financial statements from the end of FY2024. Therefore, the prior year interim consolidated financial statements have been restated after the retrospective application of the change.

As a result, operating profit, ordinary profit, and profit attributable to owners of the parent increased by ¥1,174 million, decreased by ¥1,394 million, and decreased by ¥1,136 million, respectively, compared with those before the retrospective application.
