Establishment of Joint Stock Company for Feasibility Study of LNG to Power Project in Vietnam

Tokyo Gas Co., Ltd.

Tokyo Gas Co., Ltd. (President: Takashi Uchida, "Tokyo Gas"), is pleased to announce the establishment of joint stock company, Quang Ninh LNG Power JSC ("QNLP"), together with its partner Petro Vietnam Power Corporation (President: Le Nhu Linh, "PV Power"), the largest IPP*¹ in Vietnam, COLAVI JSC (Chairman: Dinh Hoang Lien, "COLAVI"), a machinery manufacturer in Quang Ninh Province, Vietnam, and Marubeni Corporation (President: Masumi Kakinoki, "Marubeni"), a general trading company in Japan.

QNLP is established for conducting feasibility study for the LNG to power project*² in Cam Pha District, Quang Ninh Province, Vietnam, which includes an onshore LNG receiving terminal and a 1.5 GW gas-fired power plant. The scope of the project ranges from development, construction and operation of the power plant and LNG receiving terminal, LNG procurement to selling electricity to Vietnam Electricity Group. QNLP will assess the economic and technical feasibility, select EPC*³ contractor, and develop LNG procurement strategy during feasibility study phase, and aim to start the commercial operation in late 2027 subject to final investment decision by the shareholders.


