Investment in Onshore Wind Power Projects in Finland


Tokyo Gas Co., Ltd. (President: SASAYAMA Shinichi, "Tokyo Gas") has acquired two onshore wind power projects of Puhuri Oy ("Puhuri"), a Finnish renewable energy company, through TOWII Renewables A/S * ("TOWII Renewables"), a joint venture between Danish utility company EWII S/I("EWII") and TG Nordic ApS (President: SUZUKI Hiroyuki, "TG Nordic"), a wholly owned subsidiary of Tokyo Gas.

Finland is expected to further increase renewable energy capacity to achieve a target of 51% share of renewable energy in final energy consumption by 2030. These projects involve Kopsa III Wind Power Project and Ketunperä Wind Power Project, both currently under development in the city of Raahe, located in North Ostrobothnia, Finland. A total of 12 wind turbines (with a combined generation capacity of 74.4MW) will be installed, and commercial operations are scheduled to commence in the first half of 2027. This is TOWII Renewables' first investment in renewable projects beyond Danish borders.

Under its Group Management Vision "Compass 2030", Tokyo Gas Group is committed to achieving Net-Zero CO₂ emissions. Tokyo Gas Group will continue to contribute to local communities by strengthening partnerships with business partners and actively engage in project development of renewable energy sources, while maintaining capital efficiency and investment discipline.
