Participation in Nearshore Wind Power Project in Vinh Long Province, Vietnam

Tokyo Gas Co., Ltd. (President: Shinichi Sasayama, "Tokyo Gas") hereby announces to invest in Truong Thanh Duyen Hai Wind Power Joint Stock Company (Director: Nguyen Quang Vinh, "TTDH") for developing, constructing, and operating a wind power project in Vietnam, together with Truong Thanh Viet Nam Group (President: Dang Trung Kien, "TTVN") and Truong Thanh Energy (Director: Nguyen Huy Thang, "TTP"). Through this investment, Tokyo Gas has participated in the nearshore wind power project*1 ("The Project") in Vinh Long Province, Vietnam.

The Project will expand the existing nearshore wind power project operated by TTVN on the coast of Vinh Long Province, Vietnam, which was completed in 2021 with a capacity of 48,000kW, and involves the development of new 48,000kW power sources. A feasibility study based on economic rationality, technical feasibility, and other factors will be conducted in the fiscal year 2025, aiming for a final investment decision in the fiscal year 2026.

The Tokyo Gas Group, under its management vision "Compass 2030", has declared its commitment to the "Challenge of Achieving Net Zero CO₂." Going forward, we will continue to promote the acquisition of renewable energy sources in close collaboration with our business partners, while remaining mindful of capital efficiency and investment discipline. This October, the Tokyo Gas Group celebrated its 140th anniversary. We will continue to take on new challenges as a company that looks beyond Tokyo, beyond gas, and leads the way into the future.
